BOOK UP SUMMER: EVERY SUMMER, WHILE STUDENTS FROM AFFLUENT FAMILIES MAKE PROGRESS ON THEIR READING SKILLS, STUDENTS FROM LOW-INCOME FAMILIES LOSE GROUND. THE EFFECTS OF SUMMER LEARNING LOSS ARE CUMULATIVE AND ARE REGARDED AS RESPONSIBLE FOR 2/3RDS OF THE READING ACHIEVEMENT GAP. BOOK UP SUMMER ADDRESSES THIS PROBLEM, REACHING APPROXIMATELY 15,000 STUDENTS IN KINDERGARTEN THROUGH SECOND GRADE FROM HIGH-POVERTY ELEMENTARY SCHOOLS, AND GIVING THEM 12 BOOKS EACH TO READ DURING SUMMER VACATION.
